# **Key Investor Information Document**

This document provides you with key investor information about this Fund. It is not marketing material. The information is required by law to help you understand the nature and the risks of investing in this Fund. You are advised to read it so you can make an informed decision about whether to invest.

US High Yield Fund (the "Fund"), Share class : C USD (LU0688633410) is a sub-fund of iMGP (the "SICAV") managed by iM Global Partner Asset Management S.A. (the "Management Company")

### **Objectives and investment policy**

The objective of this Sub-fund is to provide its investors with a long-term appreciation of their capital. It invests in a diversified bonds portfolio with at appreciation of their capital. It invests in a diversified bonds portfolio with at least two thirds of its net assets invested in high-yield debt securities or similar high-yield instruments denominated in USD and the issuer of which is rated lower than "investment grade" as defined by at least one of the main principal world rating agencies (Baa3 by Moody's or its equivalent with any other of such rating agencies) or by the Sub-Manager's internal credit process, or in instruments for which no rating has been awarded to the issuer.


These securities will predominantly include high yield bonds (including, without limitation, unregistered (Rule 144A) notes, as well as floating and variable rate notes)

The Sub-fund promotes environmental and social characteristics according to article 8 of the Regulation (EU) 2019/2088 but does not have sustainable investment as its objective.

The Sub-Manager believes that consideration of Environmental, Social and Governance (ESG) factors in its investment process promotes long-term value creation, while also fostering or otherwise encouraging positive change. The Management Company has adopted for this purpose an ESG policy, which may be consulted on www.imgp.com. In order to achieve its objective, the Sub-fund may make use, for purposes

hedging and optimal management, of derivative financial techniques and instruments relating in particular to exchange-rate, interest-rate, credit-spread and volatility risks.

# **Risk and reward profile**



The Synthetic Risk & Reward Indicator (SRRI) is assigned due to the past or expected share class price variations resulting from its currency and the nature of the Fund's investments and strategy.

The SRRI is based on historical data and may not be a valid indication for the future risk profile of the Share Class. It is not a target or a guarantee and may change over time.

The Fund does not offer capital guarantee or asset protection measures.

The ICE BofA U.S. Non Financial High Yield index, in the appropriate currency of a given Share Class of the Sub-fund, is used for comparison only, including, for performance comparison. The Sub-fund is actively managed and the Sub-Manager's discretionary powers are not constrained by the index. Although the Sub-Manager's discretionary powers are not constrained by the index. may take into consideration the index composition, the Sub-fund may bear little resemblance to the index.

The purchase or sale of derivative instruments traded on a securities exchange or over the counter, such as interest-rate, index or currency futures contracts, options, swaps, including CDS and CDS on indices, or any derivative financial instrument having indices as underlyings, is authorized, without this list being restrictive. Exposure to CDS and CDS on indices shall not exceed 10% of the net

restrictive. Exposure to CDS and CDS on indices shall not exceed to or the net assets of the Sub-fund. For the remainder of the assets, the Sub-fund will be able to hold cash, money-market instruments or debt securities other than those described above. You may sell your shares in the Sub-fund upon request, on a daily basis. Profits are not distributed but are accumulated by the Sub-fund. Recommendation: this Sub-fund may not be appropriate for investors who plan to with draw their monoy in last than 5 years

withdraw their money in less than 5 years.

The Fund may be exposed to the following risks which are not satisfactorily captured by the SRRI and may negatively impact its assets:

**Operational risk:** Human or technical issues or errors during the processing of the transactions and/or the calculation of the NAV of the Fund may result in losses.

Liquidity risk: selling securities in low volume markets may imply a negative impact on the valuation which result in losses.

Financial Derivatives risk: Derivative transactions generate leverage which may emphasize losses whether the strategy (such as hedging, exposure, efficient portfolio management) does not react as expected under certain market conditions.

Counterparty risk: When a counterparty does not respect its obligation related to contracts such as term deposits or over-the-counter derivatives losses may occur.

Credit risk: When issuers default on their payment obligations, unexpected losses may occur on any type of assets linked to them.

Structured/Complex Fund risk: Those Funds are constructed over a specific scenario and/or may react atypically to each individual risk (among others, those mentioned in this section). In case of extreme and/or specific market conditions, Funds may become valueless.


