Japan Opportunities Fund (the "Fund"), Share class : C USD HP (LU0933609074) is a sub-fund of iMGP (the "SICAV") managed by iM Global Partner Asset Management S.A. (the "Management Company")

Objectives and investment policy

The objective of this Sub-fund is to provide its investors with capital growth; at least two thirds of the Sub-fund's assets are invested at all times in equities and least two thirds of the Sub-fund's assets are invested at all times in equities and other similar instruments issued by companies having their registered office in Japan. The Sub-fund may purchase securities traded on the regulated markets listed in section 13 "Investment restrictions" and in particular on the Jasdaq. The Sub-fund promotes environmental and social characteristics according to the article 8 of SFDR but does not have sustainable investment as its objective. The Sub-Manager believes that Environmental, Social and Governance (ESG) consideration allows for long-term value creation allowing to foster a positive

consideration allows for long-term value creation, allowing to foster a positive change. The Management Company has adopted for this purpose an ESG policy which may be consulted on www.imgp.com. For the purpose of attaining ESG characteristics promoted by the Subfund, the portfolio seeks to achieve an ESG score higher than the ESG score of the index, as measured by the Sub-Manager methodology. of the Sub-fund, for comparison mainly, including for performance comparison. Although the Sub-fund is actively managed and the Sub-Manager is not limited to investing in accordance with the composition of the index, the Sub-fund may be constrained by certain risk indicators or restrictions that refer to the index.

Information on such constrains can be obtained from the Management Company at all times

The index is a broad market weighted index which is not aligned with the environmental and social characteristics promoted by the sub-fund. The Sub-fund shall not invest more than:

10% of its net assets in units of UCITS and/or other UCIs,

10% of its net assets in REITS. The Sub-fund may also invest in derivative financial instruments in order to manage its portfolio efficiently and to protect its assets and liabilities. The Sub-fund is eligible for the partial tax exemption under GITA; to that purpose, it conclusions with consider with a second se

it complies with specific investment restrictions described in Section 13 The manager may use techniques to partially or fully protect the Sub-fund from its

exposure to currencies other than the base currency. You may sell your shares in the Sub-fund upon request, on a daily basis.

Profits are not distributed but are accumulated by the Sub-fund.

Recommendation: this Sub-fund may not be appropriate for investors who plan to withdraw their money in less than 5 years. The share class is denominated in another currency than the base currency of the Sub-fund. The exchange rate risk of this class is hedged against the base currency of the Sub-fund. However, full hedging cannot be guaranteed.


